



#### BRIGADIER GENERAL WALTER S. MCILHENNY, USMC (DECEASED)

Brigadier General Walter Stauffer "Tabasco Mac" McIlhenny was born 22 October 1910 in Washington, D.C. He received his education at Force School and Central High School in Washington, D.C., and Lane High School in Charlottesville, Virginia. He later attended the University of Virginia, also in Charlottesville. He served two years with the Washington



High School Cadets, and four years in the Virginia National Guard, attaining the rank of platoon

sergeant.

Honorably discharged from the National Guard on 15 June 1935, he enlisted in the Marine Corps Reserve and completed the Platoon Leaders' Class that summer. He was commissioned a Marine Reserve second lieutenant, 3 December 1936, with a rank date of 6 November. During subsequent summer assignments to active duty, he attended the National Rifle Matches at Camp Perry, Ohio, as an instructor and shooting member of the Marine Corps Reserve Rifle Team. He was a member of the 1937 team that won the Hilton Trophy and the A.E.F. Roumanian Trophy; coach of the 1938 team that won the Roumanian Trophy; captain of the 1939 team that won the Rattlesnake Trophy; and winner of the Bronze medal in the National Individual Rifle Match, which entitled him to the Distinguished Marksman Badge.

Prior to reporting for extended active duty in World War II, he was an engineer with the Continental Oil Company until 1940, when he joined the family firm, the McIlhenny Company of Louisiana, makers of Tabasco Sauce.

Called to active duty as a first lieutenant following the outbreak of World War II, General McIlhenny served continuously until December 1945. After completing The Basic School for Marine Corps Officers at the Philadelphia Navy Yard, he was assigned to the 5th Marine Regiment, 1st Marine Division, at New River (later Camp Lejeune), North Carolina, and served with that unit throughout the entire war. In May 1942, he embarked with the 5th Marines for Guadalcanal, where the 1st Marine Division made its initial landing on 7 August 1942 under heavy enemy fire.

For heroism as Executive Officer and later Commanding Officer of Company B, 1st Battalion, 5th Marines, during the landing on Guadalcanal and its subsequent capture and defense, he received both the Navy Cross and the Silver Star Medal. He also received two Purple Hearts for wounds received in this campaign, along with the Presidential Unit Citation that was awarded to the 1st Marine Division (Reinforced) for heroism on Guadalcanal.

In December 1943, he again participated in combat against the enemy, this time at Cape Gloucester, New Britain, as the 1st Battalion's Plans and Training Officer. He served subsequently as Regimental Intelligence Officer, and 3d Battalion Commander. In September 1944, during the landing on Peleliu, Palau Islands, he served as Regimental Plans and Training Officer. Again, he received the Presidential Unit Citation as a member of the 1st Marine Division (Reinforced). The unit was awarded the honor for heroic action in the assault and seizure of Peleliu.

On his return to the United States in December 1944, then Major McIlhenny was assigned to Marine Corps Schools, Quantico, Virginia, where he completed the Instructor's Orientation Course and served

as an instructor in the Rifle Units Section. He also completed the Artillery School at Fort Benning, Georgia, during this assignment.

Relieved from active-duty 26 December 1945, Major McIlhenny continued his affiliation with the Ready Reserve in his home state of Louisiana. He organized and trained Volunteer Training Unit 8-25 in Lafayette, Louisiana, and commanded that unit until his retirement from the Reserve. On 1 November 1959, he was placed on the retired list of Marine Reserve officers and was advanced to brigadier general by reason of having been specially commended for heroism in combat.

In addition to his Marine Corps service, General McIlhenny was one of the founders of the Marine Military Academy in Harlingen, Texas, a private military college preparatory boarding school for boys in grades 8 through 12 that remains the only school in the world to offer military leadership based on the traditions of the United States Marine Corps. Under his guidance, the Marine Military Academy has grown steadily since 1965. He supported the Academy from its very inception and was one of the original seven co-guarantors of the loan to establish the school. Many major projects were undertaken through his leadership and he is listed as a major contributor to the Academy. For many years, he served as the President of the Board of Trustees of the Academy and was the President Emeritus of the school at the time of his death.

However, Brigadier General McIlhenny was perhaps best known as the president of the McIlhenny Tabasco Sauce Company, located in New Iberia, Louisiana. His company's creation of two recipe books under his direction, *The Charlie Ration Cookbook* and *The Unofficial MRE Recipe Booklet*, and donation of thousands of bottles of the hot pepper sauce to Marines serving in Vietnam have helped make Tabasco a standard fair for those serving in the field even today.

Brigadier General McIlhenny passed away 22 June 1985 after a brief illness. He had made his home on Avery Island, Louisiana, and was laid to rest there in Grove Cemetery after a simple military service.







#### The Greatest Army Invention: History of the P38

It was developed in just 30 days in the summer of 1942 by the Subsistence Research Laboratory in Chicago. And never in its history has it been known to break, rust, need sharpening or polishing. Perhaps that is why many soldiers, past and present, regard the P-38 C-ration can opener as the Army's best invention. C-rations have long since been replaced with the more convenient Meals, Ready to Eat, but the fame of the P-38 persists, thanks to the many uses stemming from the unique blend of ingenuity and creativity all soldiers seem to have. "The P-38 is one of those tools you keep and never want to get rid of," said Sgt. Scott Kiraly, a military policeman. "I've had my P-38 since joining the Army 11 years ago and kept it because I can use it as a screwdriver, knife, anything." The most vital use of the P-38, however, is the very mission it was designed for, said Fort Monmouth, N.J., garrison commander Col. Paul Baerman. "When we had C-rations, the P-38 was your access to food; that made it the hierarchy of needs," Baerman said. "Then soldiers discovered it was an extremely simple, lightweight, multipurpose tool. I think in warfare, the simpler something is and the easier access it has, the more you're going to use it. The P-38 had all of those things going for it."

The tool acquired its name from the 38 punctures required to open a C-ration can, and from the boast that it performed with the speed of the World War II P-38 fighter plane. "Soldiers just took to the P-38 naturally," said World War II veteran John Bandola. "It was our means for eating 90 percent of the time, but we also used it for cleaning boots and fingernails, as a screwdriver, you name it. We all carried it on our dog tags or key rings." When Bandola attached his first and only P-38 to his key ring a half century ago, it accompanied him to Anzio, Salerno and through northern Italy. It was with him when World War II ended, and it's with him now. "This P-38 is a symbol of my life then," said Bandola. "The Army, the training, my fellow soldiers, all the times we shared during a world war." Sgt. Ted Paquet, swing shift supervisor in the Fort Monmouth Provost Marshal's Office, was a 17-year-old seaman serving aboard the amphibious assault ship USS New Orleans during the Vietnam war when he got his first P-38. The ship's mission was to transport Marines off the coast of Da Nang. On occasional evenings, Marines gathered near Paquet's duty position on the fantail for simple pleasures like "Cokes, cigarettes, conversation and C-rations." It was during one of these nightly sessions that Paquet came in contact with the P-38, or "John Wayne" as it's referred to in the Navy. Paquet still carries his P-38, and he still finds it useful. While driving with his older brother, Paul, their car's carburetor began to have problems. "There were no tools in the car and, almost simultaneously, both of us reached for P-38s attached to our key rings," Paquet said with a grin. "We used my P-38 to adjust the flow valve, the car worked perfectly, and we went on our merry way." Paquet's P-38 is in a special box with his dog tags, a .50-caliber round from the ship he served on, his Vietnam Service Medal, South Vietnamese money and a surrender leaflet from Operation Desert Storm provided by a nephew. "It will probably be on my dresser until the day I die," Paquet said. The feelings veterans have for the P-38 aren't hard to understand, according to 1st Sgt. Steve Wilson of the Chaplain Center and School at Fort Monmouth. "When you hang on to something for 26 years," he said, "it's very hard to give it up. That's why people keep their P-38 just like they do their dog tags. ... It means a lot. It's become part of you. You remember field problems, jumping at 3 a.m. and moving out. A P-38 has you reliving all the adventures that came with soldiering in the armed forces. Yes, the P-38 opened cans, but it did much more. Any soldier will tell you that."

Unopened vintage P-38s in their original paper wrapper are getting much harder to find and are becoming collector's

items since more and more people are putting them in their military & medal displays or their P-38 collections. P-38 collections don't cost too much and don't take up much space and they're a lot of fun finding the hard to get ones. I've had the same P-38 on my key-ring ever since my first Boy Scout camping trip when my Scoutmaster gave it to me to open the big cans of peaches for the delicious cobbler he would make over the campfire in a huge cast iron skillet. I can still taste that delicious cobbler as we sat around the campfire before crawling into our sleeping bags. My Scoutmaster was a WWII and Korean War veteran that knew how handy the little P-38s were and he gave one to every new member of the Scout troop on their first camping trip. Recently P-38s have added a new role to their long list of uses. Shelters and organizations that aid the homeless hand them out and also they were included in the humanitarian relief packets dropped into Afghanistan. I've also been told they have been handed out here in the USA by relief organizations after natural disasters (hurricanes, tornadoes, storms and floods) for when the power is out and electric can openers no longer work. A P-38 is a lesson in simplicity at it's best. Don't you wish everything in life could be as simple and useful as a P-38.


<u>Nancy Lukasik</u> – Nancy did not attend the February meeting due to experiencing some pain in trying to walk and get around.
